READ THIS FIRST: FISHING LICENSES ARE NON-REFUNDABLE

- 1) Fishing license are required for any individual, regardless of age, who wishes to fish in fresh or salt water in Mexico. This rule applies to all people fishing out of boats or fishing underwater while skin diving. A fishing license is NOT required when fishing from land.
- 2) All passengers, regardless of age, aboard a boat that is engaged in fishing in Mexican waters, must have a Mexican fishing license in their possession, whether fishing or not.
- 3) Fishing licenses are personal and non-transferable. Any alteration, mutilation or transfer of these documents will render them void and may result in fines or temporary seizure of your boat.
