In case of a refund, the premium paid will be converted to daily rates and prorated according to the number of days. All other policy rates, surcharges and option amounts are for the daily period purchased and are earned. Refund will be considered on an individual basis.

Drivers over 79 will be covered for Risks 3,4,5 and Legal only. Drivers under 21 are not eligible for coverage unless underwritten through ADA VIS Global Enterprises, Inc.

**TOWED ENCLOSED TRAILERS:** Coverage is available only on the trailer and not on the contents. Please check your homeowner's policy for possible coverage on the contents.

**SLIDE-IN CAMPERS & SHELLS** are considered separate units. Describe them as a towed unit.

**TOTAL VALUE** is the value of the vehicle plus towed units and/or camper or shell (**but not towed vehicles**). This valuation is very important. It is based on actual cash value or what you could realistically sell your unit for on the market today. (CANADIANS: these figures must be calculated in US dollars). **REMEMBER: Coverage is for actual cash value and not a flat amount.**

**FULL COVERAGE** is available for all autos and towed units **20 years and newer** and carry full coverage at home. Above this age, liability only (Risks 3,4 & 5) may be covered.

**BOAT LIABILITY** coverage is available while on water. Risks 3 and 4 are covered.

**ONE CHECK** will get it all if you wish to combine insurance with dues, ship store purchases, special activities (i.e. Crab Feed), new membership, fishing licenses and/or boat permits and FMT's. Please make the check payable to Vagabundos del Mar (VDM).

**IF YOU ARE TOWING A BOAT ON A TRAILER AND ARE LISTING AN OUTBOARD MOTOR** please give the individual values of the boat, trailer and motor. Values are not needed if you are getting only liability on these units.

**DRIVER'S LICENSE POLICY** is a limited liability policy (Risks 3 and 4 only) but covers you for any vehicle you may wish to drive in Mexico as long as it is registered. This policy is used for coverage on **Motorcycles, ATV's & Dune Buggies** if they are registered for highway use and only on established roads.

**MOTORHOMES OR BOATS ONLY** – Very special policies are available covering the US, Canada and Mexico (Mexican liability excepted). Call or write for a quote request application. If you purchase these special policies, liability coverage is all that is needed for Mexico.

**V-CODE** is a new security feature to deter fraudulent use of your credit card. The numbers are found on the signature line on the back of the card and are the last 3 digits.

### **PREFERRED PROCEDURE:**

Carefully complete the enclosed non-tourist policy application. One application is required for each self-propelled vehicle. Each self-propelled vehicle MUST have the premium figured separately.

Please make your check payable to Vagabundos – VDM. If you wish to use MasterCard, Visa or Discover please provide your credit card number, as well as the expiration date in the area designated on the application. If you have any questions, please call the office at (707) 374-5511 from 8AM to 5PM, Monday through Friday. Mail the completed application along with your check or credit card information in the return envelope.

### **OTHER OPTIONS:**

Return your application by FAX (707) 374-6843, available 24 hours a day. If required, we can return a copy of your policy by FAX (\$10 charge to Mexico, \$5 to Canada) or return the completed original policy by priority mail, Express US Mail or FED EX. Please see attached sheet for current rates on special mailing.

### **The following will be of help to you when filling out your application:**

“POLICY IS TO START ON” is the first day you want the coverage to go into effect and will run for one calendar year.

“NEED POLICY BY DATE” enables us to have the policy in your hands before you leave home. We prefer you not leave home without it.

**MEMBER NUMBER** must be included as this coverage is FOR MEMBERS ONLY. If you are applying for membership at the same time as insurance the office staff will provide a member number.

**TOWED UNITS** section is **ONLY** for pickup campers or shells, trailers (5<sup>th</sup> wheels, house or utility) or boats and trailers. It is **NOT** for a towed self-propelled vehicle. Each self-propelled vehicle must have its own application and have the premium figured separately.
