The fishing license is a legal instrument that allows you to practice the sport fishing activity, under the regulations established on the document on this control system. You must bring with you the printed fishing license, since it may be required by the corresponding authorities in compliance with the law, so when operating a boat that carries fishing equipment in Mexican waters, it is necessary to hold a valid fishing license to avoid fines and/or sanctions or non-compliance of legal regulations.

PLEASE READ: FISHING LICENSES ARE NON-REFUNDABLE

- 1) Fishing license are required for any individual, regardless of age, who wishes to fish in fresh or salt water in Mexico. This rule applies to all people fishing out of boats or fishing underwater while skin diving. A fishing license is NOT required when fishing from land.
- 2) All passengers, regardless of age, aboard a boat that is engaged in fishing in Mexican waters, must have a Mexican fishing license in their possession, whether fishing or not.
- 3) Fishing licenses are personal and non-transferable. Any alteration, mutilation or transfer of these documents will render the void and may result in fines or temporary seizure of your boat. Handle them with care!
- 4) The fishing license is individual and nontransferable By having it, fishermen are complying with the law and have the right to catch a certain number of species per day as determined through a point system. Each fisherman is entitled to fish up to 10 points. Billfish (marlin, sailfish, swordfish): 5 points* each. Dorado and roosterfish: 2.5 points* each. Other species 1 point* per specimen *You cannot catch more than 5 points of the same species per day. In Mexico we promote a 'Catch and Release' campaign and thus, only one specimen of billfish is allowed to be captured per boat, per day. Help us preserve the species reserved for sportfishing by collaborating with the campaign... Thank You!
- 5) Please note that dates in Mexico are shown as dd/mm/yyyy.
- 6) Temporary Import Boat Permits for towing, launching and marinas are now required for all of Mexico (including Baja).
