### CARAVAN TOUR AGREEMENT

1. **Reservations.** A minimum deposit of \$200 is required with all reservations. The balance is due no later than 60 days prior to the start of the caravan. The names of all the people included in your reservations must be provided.
2. **Membership requirements.** All people participating must be members of the Vagabundos del Mar Boat and Travel Club.
3. **Refunds.** The deposit will be refunded, less a \$25 cancellation fee, if cancellation is made 60 days prior to the start of the caravan.

If cancellation is made between 35 and 59 days prior to the start of the caravan, half of the reservation fee will be refunded. If cancellation is made less than 35 days prior to the start, there will be no refund of any part of the entire reservation fee.

If cancellation is made after books, caps or other items have been sent to you the cash value of those items will be retained, unless they are returned to the Club office in same condition as received.

There will not be any refund for any other reason whatsoever.

4. **Cancellation by you.** You may wish to purchase Travel Insurance, which includes cancellation by you for specified reasons. Also covered by Travel Insurance, any cancellations related to COVID-19.
5. **Terms.** If final payment is not received within 60 days prior to the start of the caravan, the Vagabundos del Mar Boat and Travel Club reserves the right to sell the space to another participant. The Club reserves the right to cancel any caravan, in which case all monies received will be refunded in full.
6. **Breakdowns.** The caravan leader will assist you to get the vehicle underway or will see you to a mechanic. Then it will be up to you. Obligations to the rest of the participants and standing reservations require the caravan to continue its itinerary with little delay. If repairs are minor, you may be able to catch up with the group. Your vehicle must be in good repair with all necessary spare equipment.

7. **Communications.** If you have your smart phone, our caravan leader(s) suggest getting a global plan for your time traveling. If you have this form of communication calls, texts and emails can be sent within the group to keep in contact.
8. **Responsibilities.** Vagabundos del Mar Boat and Travel Club is not responsible in any way whatsoever in connection with any loss, injury and/or damage, however caused or arising. Among other rights reserved, Vagabundos del Mar Boat and Travel Club or its caravan leader, may refuse to accept or retain any person as a member of a group for any reason whatsoever. Any reservation may be cancelled if circumstances demand. Itineraries, campgrounds, meals, special events and all other aspects of the caravan are subject to change without notice. You agree, that, in consideration for the organization of the caravan by Vagabundos del Mar Boat and Travel Club, you and your spouse and/or companion(s):
- Will adhere to all the rules and regulations, laws, ordinance, directions, etc. issued by the Vagabundos del Mar Boat and Travel Club, the operators of any activities included in the caravan, the federal government and the local municipality;
  - Certify that you and your spouse and/or companions are physically fit and mentally capable of participating in this caravan and,
  - Except as may be noted herein, assume all the risk, injury, loss or damage to you, your spouse and/or companions, and/or property, and agree to hold Vagabundos del Mar Boat and Travel Club, the operators of any activities included in the caravan, and the local municipality, its employees, agents, officers free of any and all liability which may arise out of or as a direct or indirect result of the caravan.
9. **Travel Consumer Restitution Corporation (TCRC).** The Vagabundos del Mar Boat and Travel Club is a participant of TCRC. You may request reimbursement from TCRC if you are owed a refund of more than \$50 for transportation or travel services which was not refunded in a timely manner by a seller of travel who was registered and participating in TCRC at the time of sale. The maximum amount which may be paid by TCRC to any one passenger is the total amount paid on behalf of the passenger to the seller of travel, not to exceed \$15,000. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to civil remedies against a registered participating seller of travel for matters arising out of a sale for which you file a claim with TCRC, if you were in California at the time of the sale.
