**Civil Liability**: This coverage protects you in the event you cause bodily injury or property damage to third parties. \$100,000 Bodily Injury Liability per Person, \$300,000 Bodily Injury Liability per Accident, \$100,000 Property Damage Liability per Accident.

**Bond and Legal Assistance:** This policy will pay up to \$20,000 USD to assist you in the event you need to deal with authorities following a covered cause of loss.
